Window Rock USD will ensure continuity of services by offering In-Person Learning for all students in PreK to 12th grade. Additional services and support provided for high school students to are lacking credits for graduation with Academic Interventionist. In addition, Window Rock USD has social/emotional processes and personnel in place to address the mental health of students both in-person and remote. Purchase supplies, equipment, and services to support the academic and emotional needs to provide a safe educational environment conducive to learning.

Students' Needs:	
Academic Needs	WRUSD hosts in-person for all students PreK to 12th grade. WRUSD will invest in hardware and software to further empower our technology capacity to enhance student learning. Provide individualized educational programs after school and on Saturday's to increase learning opportunities for all students.
Social, Emotional and Mental Health Needs	Students have access to counselors and mental health counselors to assist them with their mental health needs. WRUSD will continue to collaborate with Navajo Nation and Tsehootsooi Medical Center to meet the social, emotional and mental health needs of staff and students. Mobile Unit from Tsehootsooi Medical Center (TMC) will be on-site on Monday's to meet the needs of our high school students.
Other Needs (which may include student health and food services)	Our schools are working with TMC and with the Navajo Nation to ensure that students have access to Covid and Flu vaccination. District will host TMC at school sites for vaccinations shots. We will continue to provide breakfast and lunch every day for all enrolled students. During summer months we also operate a community feeding program that allows all community children age 18 or under to eat breakfast and lunch regardless of enrollment status.
Staff Needs:	
Social, Emotional and Mental Health Needs	Staff are also advised to utilized Employee Assistance Program for their social, emotional and mental health needs without leaving the comfort of their home. Employees also have access to TELEDOC 24/7 by app or telephone at no cost. Medical and prescription benefit coverage is available at no cost for the full-time employees.
Other Needs	Not at this time.

(b)(i) During the period of the ARP ESSER award established in section Start Printed Page 212022001(a) of the ARP Act, an LEA must regularly, but no less frequently than every six months (taking into consideration the timing of significant changes to CDC guidance on reopening schools), review and, as appropriate, revise its plan for the safe return to in-person instruction and continuity of services.
